Lakeland Joint School District will be presenting two ballot questions to voters on March 14, 2017. The first one is for an instructional/Extra curricular (Supplemental Levy) and the second one is a Plant Facility Levy. Both of these levies will replace existing levies expiring in 2017.

Lakeland School District has 4,393 students throughout eleven schools. There are 630 employees. According to Dr. Meyer, Superintendent of Schools, both the Plant Facility levy and the Supplemental Instructional/Extra Curricular levy expire this year. Unfortunately, Idaho is not a state that adequately funds its' schools — 93 out of the 115 school districts in our state require a local levy support to meet the educational needs of their students. Idaho ranked 49th nationally in per pupil spending. Lakeland has a reputation for conservative financial & fiscal responsibility.
